We need to raise \$23,000 in May and June to be able to hit our Annual estimate. Lively Issues revenue and expenses are likely to be a wash.

The office at 720 Hill Street will close when Madison Metropolitan School District cancels classes in cases of extreme cold, snow, or other hazardous conditions.

If the facility is closed during regular open business hours, staff are expected to work remotely or they may elect to use available paid time off or take leave without pay.

**In Section 5:** Add Juneteenth (Observed) as a paid holiday.
