Mary reported that planning is underway for virtual programs.

Voter Services--Paul Lindquist

Paul reported that an online "decision tree" has been created that UW students can use to decide where and how to vote. Working with the UW BadgersVote Coalition, the tool is available on the UW website - <u>vote.wisc.edu</u>. It will be shared with students in the fall via campus social media.

Fundraising--Chris Clements

Fundraising totals for May are \$1665, \$515 from Centennial Match gifts and \$1050 returned with the Annual Meeting ballot. Total Valentine's/Centennial giving for the fiscal year more than met the \$10,000 original matching gift at a total of \$23,083.

The Fundraising Committee held its final meeting of the FY on June 1 and completed the transition to the new director, Linda Dietrich. The committee would like to change their name to Fund Development Committee in the next year to better address the activities included in the workplan and bypass potential member stereotypes associated with "fundraising" that may affect committee recruitment. 
Publicity--Donna VanBogaert
