

### **High School Student Team Voter Outreach a Success!**

In January, our LWVDC High School Voter Outreach Team received a grant from LWVUS Education Fund to support student teams implementing peer voter registration and election information activities within their high school. Grant goals were to provide the teams with voter registration training, in-district support, and information outlining roles, responsibilities, and duties of elected officials on the ballot in Spring 2023 elections.

Six student teams (total of 26 students) accepted the challenge and applied for a mini-grant from LWVDC. Online training sessions in voter registration procedures were provided for each team. League volunteers worked with the teams to support voter registration activities during the February 22-March 15 registration period. Each team also planned and implemented non-partisan activities to inform their peers about the importance of voting and elections. Teams were provided bookmarks, registration materials, and funding to support their activities.

Strategies for peer voter registration varied by school. The DeForest team ran an "information station" in all senior homerooms, registering eligible students and giving presentations on voting, election dates, and candidate offices on the ballot. Several teams organized drives during lunch periods. West High School hosted a registration drive outside the auditorium during a panel presentation. The McFarland team hosted a community voter registration drive one evening. LaFollette added an extra drive during Senior Exit Day in May. A total of 150 students and staff were registered! And dozens more took information home so they could register online when they turned eighteen.

Get Out the Vote (GOTV) and election information strategies were implemented as teams engaged with peers on the importance of voting and the significance of getting registered to vote. Oregon students used school announcement videos and filmed an advertisement. Teams created posters and posted signs throughout the school. Vel Phillips Memorial High School's team reminded voters about the Supreme Court election and shared election information over social media. McFarland gave presentations to seniors during the advisory period about what was on the spring ballot and when and where to vote. Their team purchased stickers for students who registered or were already registered. Other teams used donuts, cookies, candy, and raffle prizes as encouragement to register.

This Youth Voter Registration grant project was successful in actively encouraging and supporting opportunities for student leadership. It also sparked interest and enthusiasm within the participating schools. Dan Kromer, teacher and LaFollette team advisor, said "The best part was the energy and excitement for voting that our students demonstrated." Nadia Schwedrsky, team member from McFarland High School, reported "Many students seemed very interested in voting and claimed they would vote on election day. Additionally, several students who helped out with the process were excited to learn more about elections and get more involved with several becoming poll workers for the election."

We are looking forward to expanding this high school student team approach for voter outreach in preparation for the 2024 election cycles. # **Shared Revenue Bill with Strings Attached**

The State Assembly has passed an ostensible shared revenue that offers a 15% increases in state money to local governments (except for Milwaukee, which would receive only a 10% increase). The bill would eliminate the local property tax and replace it with State funds, subject to controls over the operations of local governments, including:

- Cities, towns, and villages with populations of more than 20,000 would be required to keep police funding and staffing levels equivalent to the previous year's rates.
- County and municipal governments would be barred from placing advisory referenda on the ballot.
- Local health departments would be limited to making emergency declarations during a health crisis for only 30 days, subject to renewal for an additional 30 days.
- Local governments would be prohibited from placing limits or conditions on the operation of nonmetallic quarries.

Some provisions of the bill apply only to the City and County of Milwaukee, including requirements to:

- Transfer the Fire and Police Commission's oversight authority to the chiefs of the police and fire departments, eliminating an important check on police power.
- Assign at least 25 school resource officers to police Milwaukee Public Schools, which research shows can exacerbate racially disparate discipline outcomes and over-criminalize students.
- Prohibit spending any money generated by levying taxes on Diversity, Equity, and Inclusion positions.
- Obtain approval from a heightened two-thirds majority on the common council to authorize new program spending or positions.
- Impose limits on funding for cultural and entertainment matters.
- Prohibit the city from using sales tax revenue to pay for extending a streetcar line.
- Phase out the Milwaukee retirement system and place all new employees in the State retirement system.

The Joint Survey Committee on Tax Exemptions reported on May 15 that it found that the bill is not good public policy on a vote of 5 in favor and 4 opposed.

The bill, AB245, which is over 100 pages long, was introduced on May 3 and a hearing was held on May 4. Over 90 amendments were made to the bill by the drafters of the bill and it was presented for a vote of the Assembly with less than an hour to consider the changes. The bill was passed by the Assembly on May 17 on a vote of 56-36. A companion bill, SB301, was introduced in the State Senate on May 18 and is pending.

LWVWI has registered its opposition to these bills stating: "This bill should be amended to remove the numerous policy items not pertaining to shared revenue so they each can have the consideration needed to become law."

# **Volunteer Profile: Sally Gleason**

LWVDC proudly wears its identity as a grassroots and volunteer-led organization. Our ability to carry out our mission of "empowering voters and defending democracy" rests on the willingness of our members to take on tasks and carry them out, often without notice or fanfare. We are happy to use this space to introduce you to Sally Gleason, one of our volunteers.

If you joined the League in the last year or two and completed a member survey, there is a good chance you received a phone call from Sally, who is an outreach volunteer for the Member Service team. LWVDC is a large organization and it is not always easy for new members to figure out how they fit in. Sally is dedicated to helping new members find their way. She says, "It is gratifying to help a new member connect with the League in a manner that offers them personal growth and serves the LWVDC as well." Sally's volunteer efforts are a great example of a behind-the-scenes volunteer making a big contribution.

#### Sally, tell us a little bit about yourself

I grew up in the suburbs of Philadelphia and always had a strong interest in nutrition. While my three children were in elementary school, I decided to pursue a graduate degree in Nutritional Sciences at Case Western Reserve University in Cleveland. I still am grateful for how Ed, my husband, assumed responsibility for the children and household chores while I studied biochemistry up in our attic after dinner. After earning my degree, we moved to Madison for Ed's job, and I was hired as a clinical instructor in the Department of Nutritional Sciences at UW-Madison. After 15 years, I moved to the Waisman Center as a metabolic nutritionist managing patients with phenylketonuria (PKU), who require a very restrictive diet. To enhance their food options, I recruited a task force of research scientists and food manufacturers to develop products from the waste of cheese making. These beverages and foods greatly enhance the diet of people with PKU and are now distributed internationally—I feel this was my greatest professional accomplishment.



#### How did you get involved with LWVDC?

President Obama said in his farewell speech that change only happens when ordinary people get involved. By 2017, I had retired from my professional career and from my volunteer work teaching English to foreign students. I felt it was time for me to contribute more to civic issues. I was attracted to LWV with its goal of informing voters and defending democracy.

#### Who or what inspires you?

After living on the west side of Madison for 35 years, Ed and I moved to a condominium overlooking Lake Monona. At night I see the Capitol, a symbol of our democracy, shining across the lake. Seeing it inspires me to support the League and contribute to the strength of our democracy.

#### What do you enjoy doing in your free time?

I have always enjoyed gardening, which can be limited when one lives in a condo. However, another resident and I developed a small area on the property into an herb garden from which all residents can pick fresh herbs. Although I no longer volunteer at Olbrich Gardens, it is close enough to walk there for frequent visits. I also enjoy playing duplicate bridge with my son and with longtime friends for more than 25 years.

### **50-Year Member Recognition: Bonnie Orvick**

The League of Women Voters has a tradition of recognizing those who have been members for 50 years. Over the next few issues of the Bulletin, we will be honoring these long-time members, many of whom joined a local League elsewhere, but who are celebrating their 50<sup>th</sup> year of membership with LWV Dane County in 2023. We are grateful for the dedication of our 50-Year Members!

#### My Life Before LWV

Bonnie was raised in a small town just south of Rochester, Minnesota. When she was 10 months old her family moved off the family farm and into town, where she lived until going to college at the University of Minnesota in Minneapolis/St. Paul. Bonnie recalled her mother's involvement and support of a local congressional candidate's campaign, which provided an early exposure to civic engagement.

#### My Life with the League

Bonnie's involvement in the League has spanned several locations. While teaching at Alexandria Area



Vocational Technical School in Alexandria, Minnesota, Bonnie and a roommate joined the League. They were motivated by a study the League was conducting about water quality. Bonnie has a vivid recollection of three nuns who were also League members. The nuns themselves waded into the local lakes with baby food jars to collect the water samples to be used to analyze the impact of the growing population on the underdeveloped sewage system. The determination and passion displayed by the nuns' actions remain a vivid memory of her first experience with the League.

Bonnie and her husband moved to Modesto, California, in 1972. Bonnie joined the League in California thanks to a neighbor's influence and invitation. Once again, environmental issues caught Bonnie's attention. The League in California and Modesto was involved with land use issues as well

as air quality concerns. The population in Modesto, and throughout the Southern Central Valley of California, was burgeoning at this time. Bonnie recalls the vibrancy of the California League. There were many young women involved with the League who were at home raising their families. They invested their time and energy into League activities, including two- or three-unit meetings held each month. Bonnie's family relocated to Vincennes, a small town in southern Indiana in 1977. There was no League in the community, so Bonnie joined the AAUW (American Association of University Women). At that time AAUW's main focus was to ratify the Equal Rights Amendment. The local chapter of AAUW did not support the national focus. Bonnie's disappointment in this position, as well as the fact that she missed the grassroots participation and "bottom-up" structure of the League of Women Voters, moved her to help establish a local League chapter. In 1980, with the help of a friend and an Indiana state legislator, the League of Women Voters of Knox County was established. Throughout the next 30 years, Bonnie was active in the local League as well as serving on the state LWV Indiana Board for two terms. Bonnie recalls encouraging many of the young women in her community to join the League. As a result, there was a strong core of women involved with the primary focus of addressing local issues.

In 2010, Bonnie moved to Madison to be closer to family members. She joined the League here immediately. Her role has changed from being an activist in the League to being an advocate of the League! Bonnie credits the League with helping her to gain leadership skills. She greatly appreciates the extensive knowledge she has acquired and all that she has learned through her involvement in the League.
